This guide is split into sections below to provide what resources you need, where to go and any extra info

The priority listings are to advise you on which order is best to pursue things to avoid any significant interruption of access to banking and the likes!

KNOW YOUR RIGHTS! As per Article 16 of GDPR, entities must update your information "Without due delay".

Report to IMY/Finansinspektionen if any entities fail to update your data within 5 working days.

Do NOT take any excuses as a valid explanation for why such a change is taking a long time, this includes "we've never seen somebody change personnummer before"

Specific info for overseas citizens in Sweden or Swedish Citizens overseas

Skatteverket will honour a gender marker change that has been performed overseas, as long as you are a citizen of that respective nation or resident at the time of the change (The latter can apply to Swedish citizens abroad)

The primary sources that they refer to is a Passport or Population Register extract for a change. Note that some countries such as the UK do not have a Population Register. Therefore, for countries such as the UK, it is only possible to use this overseas route if you are a British citizen.

Primary source for this info - Change of Personnummer (In Swedish)

If any further evidence is requested when you have shown SKV the new Passport, contact the Case Handler (Handläggare) with the above link as a point of reference

United Kingdom - Only a Passport change is needed and not a GRC, a GRC only allows the change of Birth/Marriage/Death Certificates

It also means you've got a backup payment card for now and the future as well as Bank Accounts not only in SEK!
